- 1 PROHIBITED STREET OR AREA means a street or area in which street trading is prohibited.
- 2 CONSENT STREET OR AREA means a street or area in which street trading is prohibited without consent of the City Council Licensing Manager and Director of Governance.
- 3 STREET TRADING means the selling or exposing or offering for sale any article (including a living thing) in a street or from a stationary van, cart, barrow or other vehicle
- 4 You are not required to disclose matters which are exempt by the Rehabilitation of Offenders Act 1974.
- 5 You should enclose the following with your completed application form
 - The licence fee
 - A deposit of £25 in respect of the licence plate for a new application
 - Vehicle insurance certificate
 - Vehicle registration document
 - Current MOT certificate
 - Public liability insurance indicating amount of cover and expiry.
- 6 Remittance should be made payable to the 'City of Carlisle'
- 7 If the application is signed on behalf of a limited company the applicant should state in what capacity he/she signs.
- 8 There are penalties for knowingly giving false information in respect of this application.
