Through the Design Foundations Competition, Innovate UK aims to help businesses develop new ideas that will deliver benefits for people and the planet, aligned with the UN's Sustainable Development Goals. These can be for new or significantly improved products, services, places or business models.

The deadline for applications to be submitted is 31 August 2022 (11am).



## Communities - Urban & Rural Development

### Launch of GambleAware's Community Resilience Fund

Funding to address gambling-related harms which may have been exacerbated by the cost-of-living crisis in Great Britain.

The deadline to apply is 12noon on 28 July 2022.

### Movement for Good Awards Accepting Nominations for September Draw

The Movement for Good Awards is an annual platform for giving, set up by all the businesses that make up the Benefact Group as a way to make a 'tangible difference' to the lives of the people and communities they serve.

The deadline for applications is 5 February 2023.

### **Funding to Support Long-Term Recovery from Gambling-Related Harms**

A new grants programme to help those affected by gambling to rebuild and recover in Great Britain.

The deadline to apply is 12noon on 15 August 2022.

### **GlaxoSmithKline (GSK) IMPACT Awards Open for 2023 Round**

The annual awards scheme for charities improving health and wellbeing is now accepting applications.

The deadline for Stage One applications is 5pm on 1 September 2022.

### **Pink Ribbon Foundation Announces Deadline for 2023 Applications**

Funding to address the needs of people who are suffering from, or have been affected by, breast cancer and to advance understanding of the condition.

The deadline to apply is 26 May 2023.
