

THE CITY OF CARLISLE (REMEMBRANCE PARADE) ORDER 2022
THURSDAY 11 TO SUNDAY 14 NOVEMBER 2022

ORDER UNDER SECTION 21 OF THE TOWN POLICE CLAUSES ACT 1847
FOR THE PREVENTION OF OBSTRUCTION ETC

NOTICE is hereby given that whereas during certain hours from Friday 11 November 2022 to Sunday 13 November 2022 certain highways in Carlisle will be thronged and liable to obstruction for the purpose of observance by the public of an annual parade and Remembrance Service and the City Council of Carlisle pursuant to powers conferred by Section 21 of the Town Police Clauses Act 1847 has made an Order that for the purpose of preventing obstruction in the said highways the following regulations shall be observed:

1. The following highways or roads will be closed to vehicular traffic between 10:45 hours and 12:00 hours on Friday 11 November 2022 ("the First Date") as follows:
 - (a) That highway or road or length of highway or road (adopted as maintainable at the public expense) known as Castle Street commencing from its junction with St Mary's Gate to its junction with The Green Market and that area of the Town Centre known as the Green Market shown coloured orange on the plan attached hereto and marked "Plan 1" ("Plan 1") will be closed to vehicular traffic between approximately 10:45 hours and 11:05 hours and between 11:30 hours and 12:00 hours.
2. The following highways or roads will be closed to vehicular traffic between 10:45 hours and 12:00 hours on Sunday 13 November 2022 ("the Second Date") as follows:
 - (a) That highway or road or length of highway or road (adopted as maintainable at the public expense) comprising of Eastbound and Westbound carriageways of the A595 known as Castle Way commencing from the Castle directly across Castle Way to its junction with Castle Street shown coloured orange on the plan attached hereto and marked "Plan 2" ("Plan 2") will be closed to vehicular traffic for two periods of approximately 15 minutes between 10:45 hours and 11:05 hours and between 11:30 hours and 12:00 hours;
 - (b) That highway or roads or length of highway or road (adopted as maintainable at the public expense) known as Castle Street from its junction with Finkle Street and Annetwell Street to its junction with The Green Market and that area of the Town Centre known as the Green Market shown coloured orange on Plan 1 will be closed to vehicular traffic between 10:45 hours and 11:10 hours and between 11:30 hours and 12:00 hours;
 - (c) That highway or roads or length of highway or road (adopted as maintainable at the public expense) known as Finkle Street from its junction with Castle Street to its junction with Annetwell will be closed to vehicular traffic between 10:45 hours and 11:10 hours and between 11:30 hours and 12:00 hours;
 - (d) That highway or road or length of highway or road (adopted as maintainable at public expense) known as Annetwell Street from its junction with Castle

Street to its junction with Finkle Street will be closed to vehicular traffic between 10:45 hours and 11:05 hours and between 11:30 hours and 12:00 hours.

3. Nothing in this Order shall apply to anything done under the direction of or with the permission of a Police Officer in uniform or a Traffic Warden nor shall prejudice any right on the part of the highway or other appropriate Authority to take proceedings for any infringement, incursion or obstruction of any footpath or highway under the Highways Act 1980 or any other applicable enactment or the common law.
4. All persons with a vehicle will accordingly have to take alternative routes as appropriate other than those specified in this Order between the times specified therein on the First Date and the Second Date.

The Order and explanatory maps showing the extent of the closures and restrictions may be inspected at the Customer Contact Centre, Ground Floor, Civic Centre, Rickergate, Carlisle between the hours of 9.00 a.m. and 5.00 p.m. Mondays to Thursdays and between 9.00 a.m. and 4.00 p.m. on Fridays up to close of business on Friday 11 November 2022 or on the City Council's Website <https://www.carlisle.gov.uk/open-data/Publication-Scheme/Legal-Notices>.
