For electrical work not covered under a Competent Person Scheme, please refer to "Electrical Work" within the minimum charges section of schedule 3. For the addition of new circuit(s), the basic inspection fee will be £65.00 plus VAT (account will be given to repetitive work and a discount may apply).

We would plan to carry out a minimum of a commencement/foundation, floor preparation, floor joist/roof structure, drainage and occupation/completion inspection on an extension although depending on the complexity of the project additional inspection will be carried out and we reserve the right to carry out additional inspections as we deem necessary.

- 1) There shall be a 25% reduction in the plan charge in relation to repetitive work on more than one building where all such buildings are contained within the same application or Building Notice.
- 2) There shall be a 25% reduction in the plan charge or the plan charge element of the Building Notice charge in respect of building work that has previously been approved under Building Regulations by Carlisle City Council.
- 3) Where the work comprises, or includes the erection of more than one extension to a single private dwelling, the total floor areas of all such extensions are to be aggregated in determining the charge payable in accordance with the above table (TABLE 2), and where the aggregated floor area exceeds 60m² the charge payable will be in accordance with TABLE 3 of Schedule 3.
