

THE COUNTY OF CUMBRIA (FOOTPATH NO. 111005 IN THE PARISH OF
CUMMERSDALE AND FOOTPATH NO. 114053 IN THE PARISH OF DALSTON)
(TEMPORARY PROHIBITION OF PEDESTRIANS) ORDER 2022

NOTICE IS HEREBY GIVEN that to enable works to be carried out for the diversion of Northern Gas Networks High Pressure Gas main to enable the future construction of the new Carlisle Southern Link Road (“the Works”), the County Council of Cumbria intends to make an Order the effect of which is to prohibit pedestrians from proceeding along the following lengths of footpath:

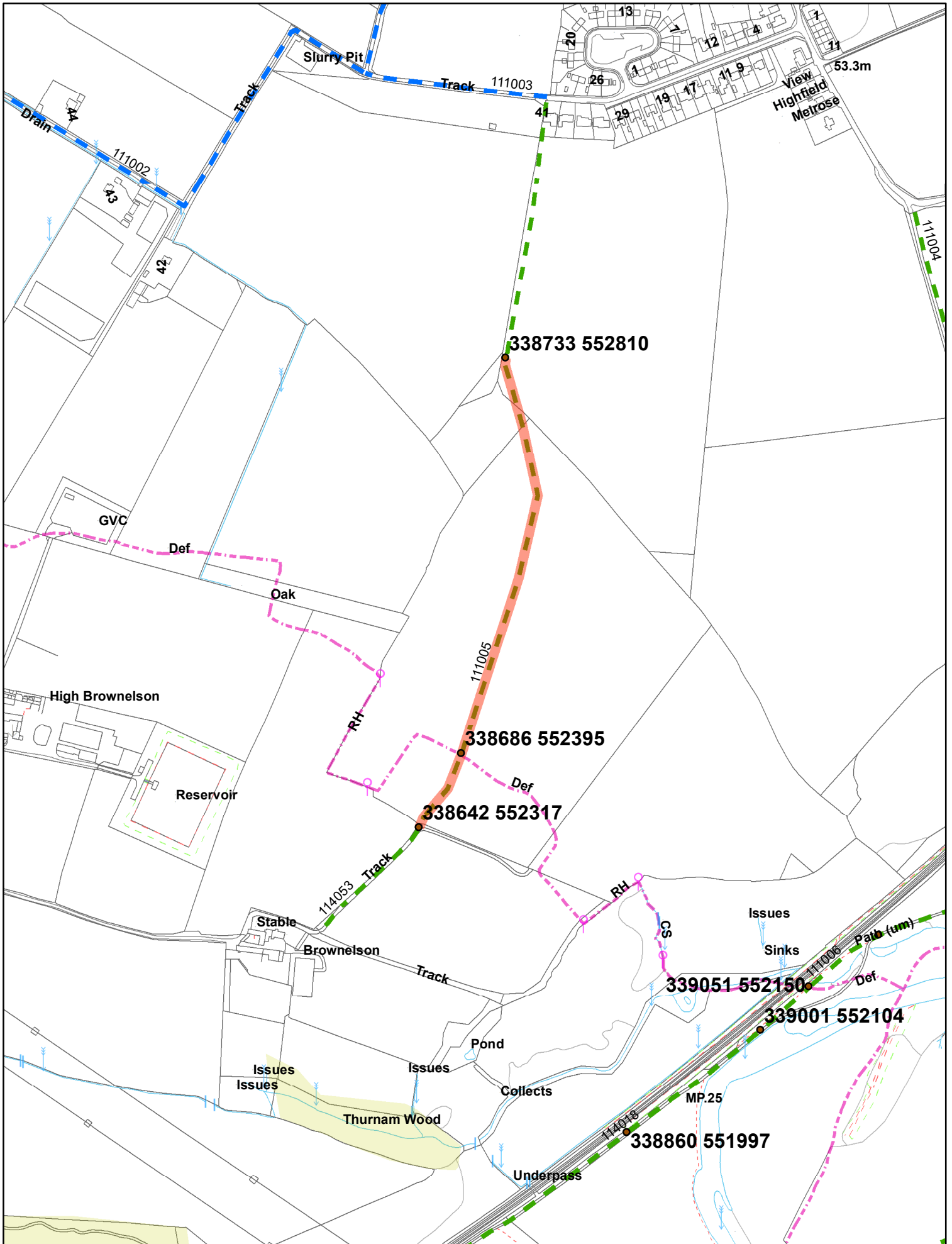
1. An approx. 431 metre section of Public Footpath No. 111005 in the Parish of Cummersdale, between Grid References: 338733, 552810 and 338686 552395; and
2. An approx. 91 metre section of Public Footpath No. 114053 in the Parish of Dalston between Grid References: 338686 552395 and 338642 552317.

There is no suitable alternative route available for pedestrians.

The Order will come into operation on 1 July 2022 and may continue in force for a period of up to six months from that date as and when the appropriate traffic signs are displayed.

THE COUNTY OF CUMBRIA (FOOTPATH NO. 111005 IN THE PARISH OF CUMMERSDALE AND FOOTPATH NO. 114053 IN THE PARISH OF DALSTON) (TEMPORARY PROHIBITION OF PEDESTRIANS) ORDER 2022

WHEREAS the County Council of Cumbria (hereinafter referred to as “the Council”) being the traffic authority for Footpath No. 111005 in the Parish of Cummersdale and Footpath No. 114053 in the Parish of Dalston is satisfied that pedestrian traffic in the said roads (footpaths) should be restricted by reason of works being proposed to be executed thereon and near the roads (footpaths) (“the Works”).

NOW THEREFORE the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers them enabling in that behalf hereby make the following Order.

1. No person shall proceed along the following lengths of footpath:
 - (i) An approx. 431 metre section of Public Footpath No. 111005 in the Parish of Cummersdale, between Grid References: 338733, 552810 and 338686 552395; and
 - (ii) An approx. 91 metre section of Public Footpath No. 114053 in the Parish of Dalston between Grid References: 338686 552395 and 338642 552317.

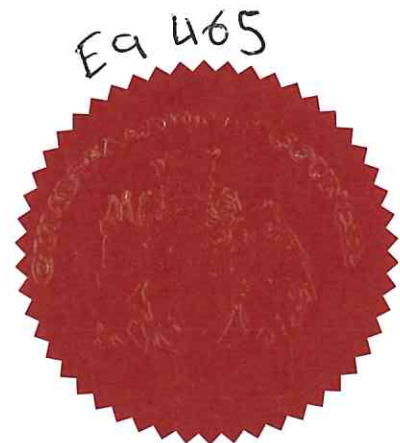
2. Nothing in this Order shall apply other than at such times and to such extent as is indicated by the appropriate traffic signs.

3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

4. This Order shall come into operation on the first day of July 2022 and may be cited as The County of Cumbria (Footpath No. 111005 in the Parish of Cummersdale and Footpath No. 114053 in the Parish of Dalston) (Temporary Prohibition of Pedestrians) Order 2022.
