

THE CITY OF CARLISLE (QUEEN'S BATON) ORDER 2022
SATURDAY 16 JULY 2022

ORDER UNDER SECTION 21 OF THE TOWN POLICE CLAUSES ACT 1847
FOR THE PREVENTION OF OBSTRUCTION ETC

NOTICE is hereby given that whereas during certain hours on Saturday 16 July 2022 ("the Date") certain highways in Carlisle will be thronged and liable to obstruction for the purpose of observance by the public of a Queen's Baton relay the City Council of Carlisle pursuant to powers conferred by Section 21 of the Town Police Clauses Act 1847 has made an Order that for the purpose of preventing obstruction in the said highways the following regulations shall be observed:

1. The following highways or roads will be closed to vehicular traffic between 0700 hours and 1000 hours on the Date as follows:
 - (a) That highway or road or length of highway or road (adopted as maintainable at the public expense) known as the bus lane on Devonshire Street together with the disabled parking bays from its junction with Devonshire Street to its junction with Lowther Street shown coloured orange on the attached plan ("the Plan");
 - (b) That highway or roads or length of highway or road (adopted as maintainable at the public expense) known as the disabled parking bays on English Street form 61 English Street to the junction with Devonshire Street shown coloured orange on the Plan;
2. The following highways or roads will be closed to vehicular traffic between 0700 hours and 1000 hours on the Date as follows:
 - (a) That highway or roads or length of highway or road (adopted as maintainable at the public expense) known as Market street from its junction with West Tower Street to its junction with Fisher Street, Fisher Street from its junction with Market Street to its junction with Finkle Street, Finkle Street from its junction with Fisher Street to its junction with Castle Street, Castle Street from its junction with Finkle Street to its junction with Paternoster Row, Paternoster Row from its junction with Castle Street to its junction with Abbey Street, Abbey Street from its junction with Paternoster Row to its junction with and Annetwell Street from its junction with Abbey Street to its junction with Castle Street shown coloured orange on the Plan;
3. Nothing in this Order shall apply to anything done under the direction of or with the permission of a Police Officer in uniform or a Traffic Warden nor shall prejudice any right on the part of the highway or other appropriate Authority to take proceedings for any infringement, incursion or obstruction of any footpath or highway under the Highways Act 1980 or any other applicable enactment or the common law.
4. This Order will come into operation at 07:00 hours on 16 July 2022 and may be cited as the City of Carlisle (Queen's Baton) Order 2022.

The Order and explanatory maps showing the extent of the closures and restrictions may be inspected at the Customer Contact Centre, Ground Floor, Civic Centre, Rickergate, Carlisle between the hours of 9.00 a.m. and 5.00 p.m. Mondays to Thursdays and between 9.00 a.m. and 4.00 p.m. on Fridays up to close of business on Friday 15 July 2022 or on Carlisle City Council's website, <https://www.carlisle.gov.uk/Residents/Roads-Highways-pavements/Roads-and-Highways-Closures>.
