**Adoption Statement**

**Carlisle District Local Plan 2015 – 2030**

Notice is hereby given that Carlisle City Council adopted the above Local Plan on 8<sup>th</sup> November 2016 by a Council resolution. This adoption statement is set out in accordance with Regulations 26 and 35 of the above regulations.

The Local Plan was examined by an independent Inspector Mrs Claire Sherratt DIP URP MRTPI, and hearing sessions were held between 1-3 December 2015 and 19-20 January 2016. The Inspector's report (25<sup>th</sup> July 2016) concludes that subject to the recommended main modifications the Plan is sound, legally compliant and capable of adoption.

The Carlisle District Local Plan 2015 – 2030 is a full local plan containing strategic policies, development management policies and site allocations. It replaces the Carlisle District Local Plan 2001 – 2016. The Adopted version of the Local Plan incorporates all of the main modifications set out in Appendix 1 of the Inspector's report and the Council's additional minor modifications.
